



TERMS OF USE

Last Revised: February 5, 2014

These Terms of Use shall apply to all websites owned and/or operated by the IVSN Group LLC including without limitation the website on which these Terms of Use are posted and IVSN's parents, subsidiary and/or affiliate entities whether or not referred to directly as IVSN or The IVSN Group LLC IVSN maintains this and other websites as a service to its customers.
